Overview

Only software products that have completed the My Health Record conformance process can connect to and upload information to My Health Record. These software products are also referred to as 'conformant software'.

You can check the list below to see if your pathology or radiology system is conformant.

How do I connect to My Health Record and begin uploading reports?

Following successful registration of your pathology laboratory or radiology practice you will need to use conformant software to connect to My Health Record so you can begin to share reports.

Is my pathology or radiology software conformant?

A number of organisations offer conformant software and they will be able to assist you with connecting to My Health Record. You can contact these organisations directly for support and assistance to ensure you are able to upload reports to My Health Record.

Additional software organisations are currently undertaking conformance processes to enable them to connect to My Health Record. If your pathology or radiology software is not listed below, you should contact your software organisation directly to see if they will enable uploads to My Health Record.

If your radiology information system or pathology information system is not conformant software, there may be additional options (see page 2) for you to share reports with My Health Record.

What if my radiology or pathology software is not conformant?

You may be able to use a secure messaging service provider to upload pathology and diagnostic imaging reports to My Health Record. You can contact your secure messaging service directly if you wish to discuss whether they can assist you with connecting to My Health Record.

I have in-house developed software or use a hospital electronic medical record (EMR) and I would like to connect to My Health Record, can this be supported?

There is the option for you to undertake conformance activities so that connection and uploading to My Health Record can be performed within your pathology or radiology information system or other software, such as a hospital EMR.

Additionally, this can be achieved using the Australian Digital Health Agency's conformant middleware solution, Health Information Provider Service (HIPS).

If your software currently enables uploading of pathology or diagnostic imaging reports, this will enable you to comply with the Share by Default requirements.
